免責條款

- 1. 此報價單並不包括清除雜物,請於搬運前清理好。
- 2. 請於搬運日前收拾及清空各個櫃內之雜物。如搬運當日客人未能執拾物品,導致搬運過程受阻礙,將會加收單價每30分鐘30%作等候費。(如搬運費\$2000,每30分鐘\$2000*30%計算)。

 (For example, the transport fee is \$2000, \$2000*30% every 30 minutes).

If customer did not declare in original quotation the following: a) goods need to be carried via staircase, b) platform transfer to elevator and moving the goods distance to our truck by more than 100 meters, there will be a extra surcharge fee (based on per floor and/or each 100 meters) on top of the total moving fee.
